Family of New Jersey woman who died after neck surgery to get \$4.2 million in settlement

The son of a Burlington County woman who died after neck surgery is set to receive \$4.2 million to settle a case involving a doctor who was allegedly out driving and making phone calls instead of remotely monitoring the operation.

Margaret Mary Niedzwiadek, 59, of Southampton, suffered a catastrophic brain injury because of an October 2013 surgery at AtlantiCare Regional Medical Center, according to a lawsuit filed by her coma until she died in December 2013.

The suit claimed that the doctor, Craig J. Anmuth, was driving to the office, talking on his cellphone, and reviewing other patients' medical records while he was supposed to be watching Margaret Neuromonitoring Technologies, based Niedzwiadek's neuromonitoring signals at Bacharach Institute for Rehabilitation in Galloway Township. Neuromonitoring is used to assess the functional integrity of the brain during surgery.

The medical malpractice suit, filed in \$1.1 million from Perro and Neuromon-New Jersey Superior Court in Atlantic itoring Technologies, and \$100,000 County, also alleged that the neuromonitoring technician in the operating room, Robert Perro, failed to tell surgeons Trunk, who represented Niedzwiadek's about her grave signal changes. Anmuth had testified that he had been watching from the start of Niedzwiadek's surgery and that he must have lost his internet connection before the signal changes, according to court papers. But evidence showed that Anmuth had not logged in to the surgery until nearly 50 minutes after it began, and that he had sent and received seven phone calls, including one with a plumber, during the surgery, David Niedzwiadek said in court filings.
