\$51M lawyer credits teaching experience

Mark McGuire and Sammy Sosa have nothing on Tom Kline.

Kline has emerged as the "Babe Ruth" of ersonal injury litigation, as one attorney put it.

put it.

Kline is the Philadelphia lawyer who cleaned SEPTA's clock in the SSI-million verdict after a subway escalator accident ripped off a 4-year-old boy's foot.

The victory for the boy, Shareif Hall, and his mother, Deneen Hall, caps a 14-month run in which Kline has smacked quite a few out of the park. few out of the park.

Since October 1998, Kline has won four cases with verdicts totaling \$114.3 million. Another dozen cases settled for multi-million dollar payouts.

"If major injury litigation were baseball, Tom Kline would be Babe Ruth," said Ger-ard G. Bernhardt Jr., a Center City lawyer

who also handles personal-injury cases.
Like star athletes, Kline is well compensated for his work. Barring a reduction from appeals, Kline's cut on the four recent cases he won is estimated at more than \$30 million. But unlike many spoiled athletes, Kline is not doing it for the glory, observers say

There are lots of good lawyers who just

do their job," said Judge Mark I. Bernstein.
"But with Tom Kline, you can tell he cares."

Kline often represents the poor or disenfranchised Many have been maimed or mistreated by doctors, hospitals or drug companies. Kline shares a special bond with mistreated cancer patients, since both of his parents died from the disease.

Kline, 52, takes on powerful institutions with a vengeance. By the time Kline got through with SEPTA earlier this month, the transit agency did not even offer a defense. Kline's special talent comes from an ability to connect with juries. Despite Kline's penchant for \$2,000 black suits and designer glasses, his genuine concern shines through. Kline can take a complicated case and separate right from wrong. After playing to a jury's head, he goes for the

In the SEPTA case, the first piece of evidence Kline intro-duced was Shareif's ripped black sneaker, followed by his torn sock and shredded pants, Near the end of trial, Shareif limped into court, his mother removed his prosthesis and revealed his butchered limb. Some jurors looked away in horror. Others cried.

Good trial lawyers perform in court in a case involving a deaf and blind boy named Tommie, Kline sang "The Who" song with the same name. Kline has put on

Before going to law school, Kline spent six years teach-ing social studies in Freeland, Pa., popula-tion 6,000. Keeping students engaged requires the ability to perform and make complicated things easy to understand. Kline believes his est courtroom training occurred in the classroom.

"Sixth-graders are too smart and too savvy to talk down to," he said. "It's the same way

with juries."
Many of Kline's cases are malpractice suits against prestigious hospitals and doctors. Kline cuts through complicated medical jar-

gon. Big words used by doctors, like "hypertensive," get translated into "high blood pressure." Heaven help the witness who tries to tell only part of the truth. Those caught in Kline's crosshairs often leave the wit-ness stand in a pool of sweat.

In one case a defense team wit-ness lacked formal education in epidemiology. Kline asked about his schooling. The witness, an ac-



complished doctor, said he en-rolled in a course but did not complete the work.

wait more than an hour for an ambu-lance to take him to another hospital. A witness for the defense tried to offer a convoluted explanation to justify the de-

lay.

Kline asked the witness if he ever ordered take-out food or called for a taxt. And when your food or cab didn't arrive, what did you do?, Kline asked the wit-ness. The witness said he called back.

"Well don't you think Dennis Richardson deserved at least the same atten-

tion you give when calling for a taxi?" Kline de-

manded.

The case settled for "a ton of money," he said.

Thomas R. Kline was born in Hazleton, Pa., an old coal town just west of the Poconos. His father, Isadore, managed a dress factory and his mother, Jeanne, was a homemaker who raised Kline and his sister.

Kline's parents shaped his val-es and work ethic. In Kline's office is his baseball mitt with a ball signed by Ted Williams that his dad caught in Yankee Stadi-

Kline lives with his wife of 27-years, Paula, and two chil-dren, Hilary, 20, and Zachary, 15, in a SI million house in Society Hill He has a vacation home on Long Beach Island. Kline plays squash at the Racquet Club and enjoys courtside seats to the Six-

Despite great wealth, Kline remains grounded. He enjoys pizza at Marra's in South Philly. In the middle of a recent trial, he brought his son to Temple's Apol-

lo for Bob Dylan's concert.

During trials, Kline ents and sleeps the case. He keeps a notebook by his bed. When in court, Kline's diet consists of soft pretzels and Mike & Ike candy.

"Everytime I stand up to give an opening speech I know some-one's future is riding on what I do," he said. "Those are big

A little more than a week after

A little more than a week after the SEPTA trial, Kline already has his eye on the next big stake. Kline is representing an Upper Darby auto mechanic left para-lyzed and without speech after receiving experimental radiation treatments at Thomas Jefferson

University.

The trial is scheduled to begin

in February. Kline can't wait.
"They are going to be on the hot seat," he said.

On the wall is a typed letter from his father dated 1969 that reads, in part, "I know mother and I will always be proud of you." Kline's upbringing keeps him grounded and helps him re-late to his clients and juries.

"I take every opportunity I can to remind myself where I came

from," he said. Kline was the first in his family to go to college. He graduated from Albright College in 1969 and received a master's in American history from Lehigh Univer-sity in 1971. He began teaching

elementary school and later re-turned to law school, graduating from Duquesne University in

Kline spent a year as a clerk Kind spent a year as a ciers, for state supreme Court Judge Thomas W. Pomeroy. In 1980, Kline came to Philadelphia to work for James Beasley. He left Beasley in 1995 to form his own firm with Shanin Specter, son of

U.S. Sen. Arlen Specter.
Philadelphia magazine named Kline and Specter the top person-al injury lawyers in the city, and Kline was selected to the Inner
